With tight budgets and increased scrutiny on Federal spending, agencies need to get the most from each dollar spent. As the world's largest purchaser—with a projected 2017 annual spend of over \$4 trillion—the US government wields considerable purchasing power.

Legislation such as the Digital Accountability & Transparency Act (DATA) and the Federal IT Acquisition Reform Act (FITARA) are helping to improve the process, yet the burden of implementation is shouldered by the agencies. And spend data often lives in silos, making it difficult to identify savings opportunities.
